PAYMENT TERMS. According to the contract, the payment should be made by "Exponent" according to the registered invoice, to the settlement account indicated by the Chamber of Commerce and Industry of Turkmenistan (hereinafter referred to as "Guramachy") under the conditions of 100% advance payment. For an advance payment, the Exhibitor is admitted to the exhibition grounds and to the organization of the exposition. Exponent shall pay the commission fees for bank and correspondent bank transfers in full. The date of payment is calculated from the day when funds are transferred to the settlement account of the "Guramachy". "Exponent" guarantees to transfer (pay) the payment if funds are not transferred to the Guramachy's account on time. In accordance with the legislation in force in Turkmenistan, "Exponent" may withdraw any amount of money from any accounts (accounts, currency, deposit and other accounts) and any amount of money in any banks, including "Exponent's units (enterprise, branch and representative office) in an unaccepted manner, without additional instructions of "Exponent". entitles. According to the legislation in force in Turkmenistan, on the basis of the "Exponent's" instruction, the "Organizer" undertakes to transfer the payment for the specified room from the hotel to the hotel's currency account in foreign currency according to the invoice.


